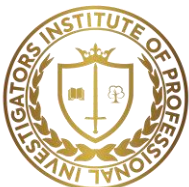

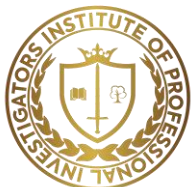
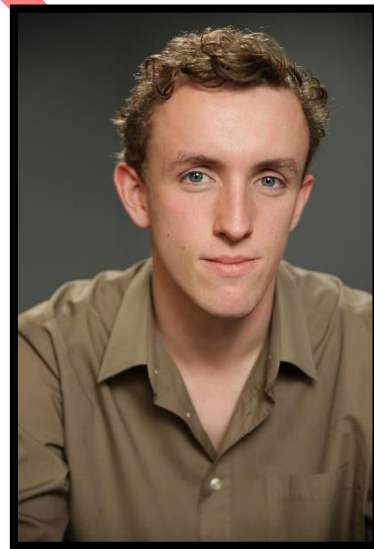

Brief History

To perform surveillance on our client's wife via directed surveillance. Should our subject meet with the believed third party male we are to switch subjects to him and house him to gain his identity.

Summary of Operations

Tuesday 2nd November 2021

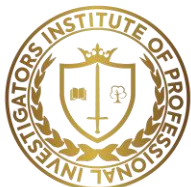
A planned deployment started at the home address of Charlotte Smith – 23 Nottingham Street, Nottingham, NG1 1NG where she was recorded exiting alone and walking to her car.

Charlotte then drove to a nearby McDonalds – NG2 2NG and met with James Bloggs. Charlotte had a drink ready for his arrival. Here the two kissed and sat briefly before departing in their own respective vehicles.

Both Charlotte and James were followed via mobile surveillance to Wollaton Park – NG3 3NG. At this location the subjects changed their clothing to suit the weather and went for a walk within the park towards the café. After purchasing hot drinks at the café, the pair moved to a nearby bench and shared more kisses.

From here the pair moved back to their vehicles and shared another kiss and embrace before departing in their separate vehicles to a nearby pub, Nottingham Arms – NG4 4NG. Within the pub the pair had a meal together, no alcohol was consumed.

Once finished the pair exited to their vehicles and said their goodbyes with more kisses and embraces. The pair departed in their respective vehicles going in different directions. At this point in the surveillance period the main subject became James who was followed to a residential address – 123 Carlton Street, Nottingham, NG1 2NG. Open-source investigations place this as James' home address which evidences him further as James Bloggs. This was the last sighting of James and observations were closed here.

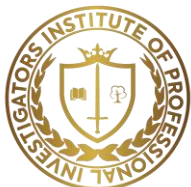

Surveillance Synopsis

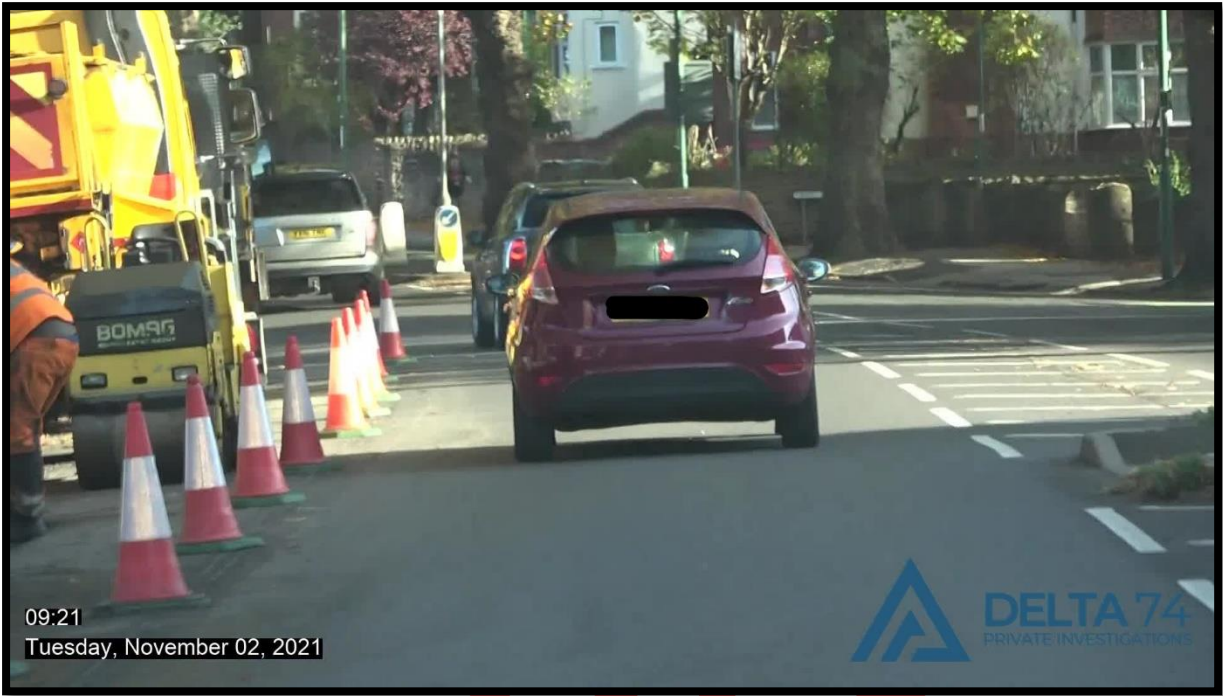
Tuesday 2nd November 2021

09:14 Observations commenced at the home address. Charlotte exited her home address and walked towards her vehicle.

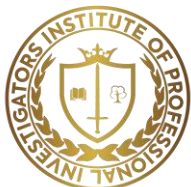

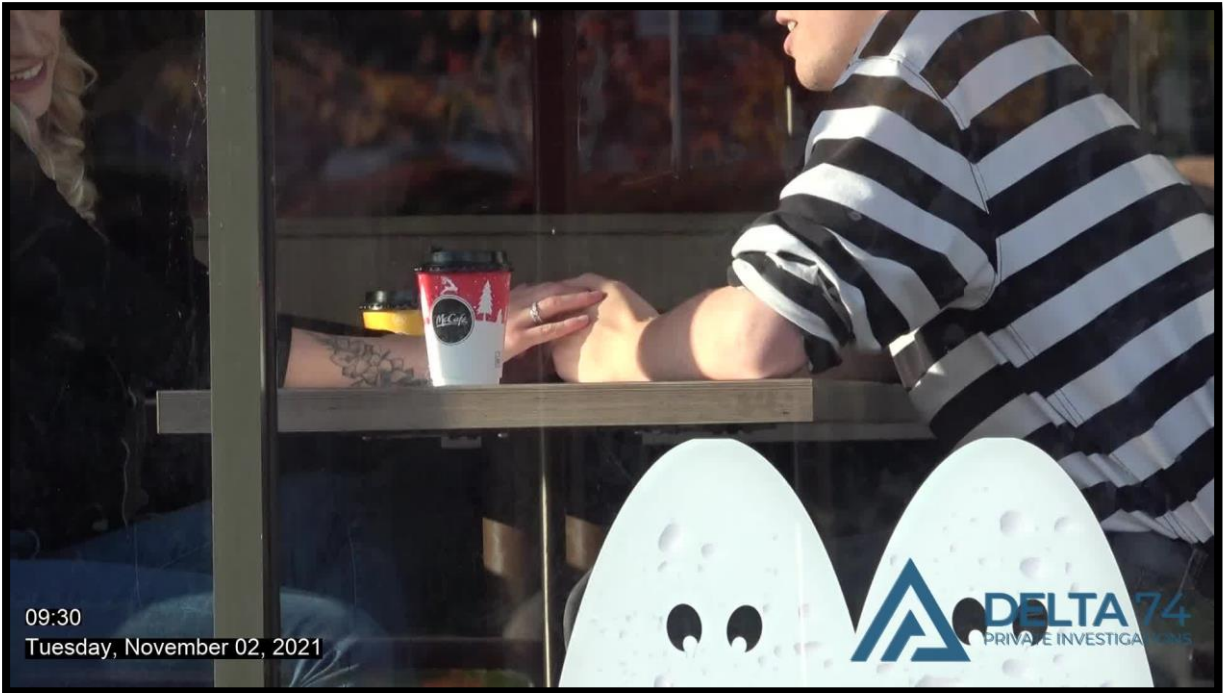

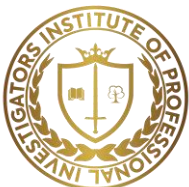

09:32 An operative moved in to listen to conversation and 'Wollaton Park' was overheard with no context at that time,



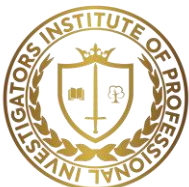
09:33 The pair gathered their items and prepared to depart.



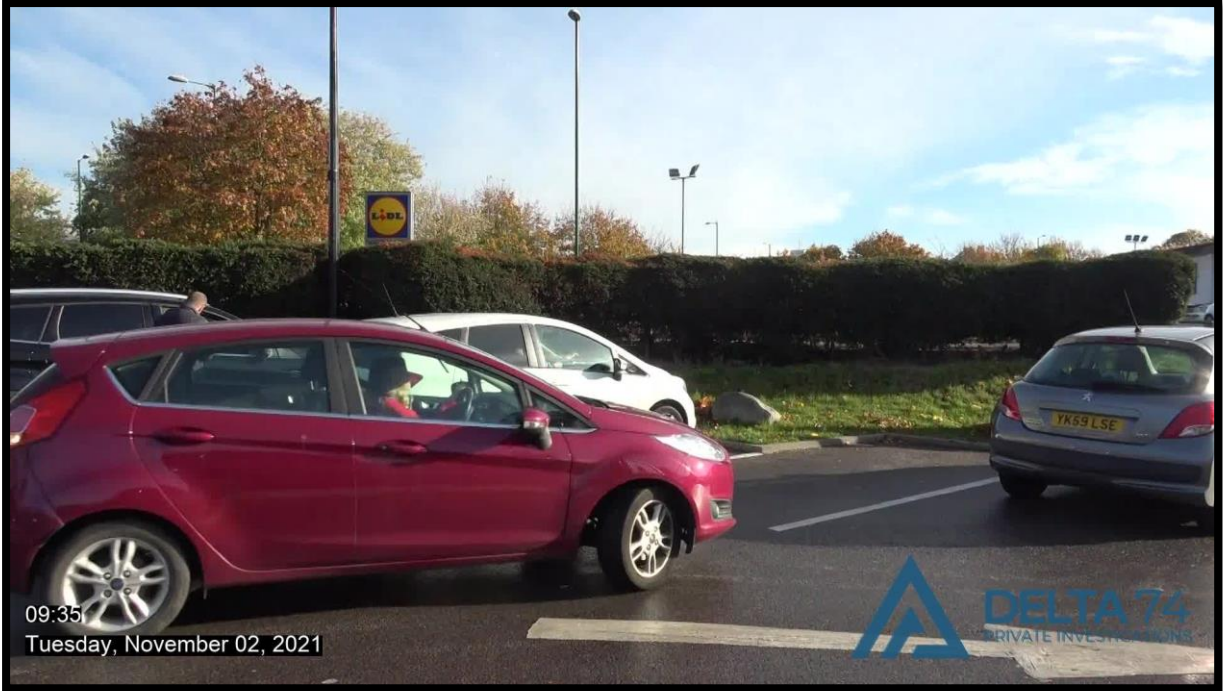

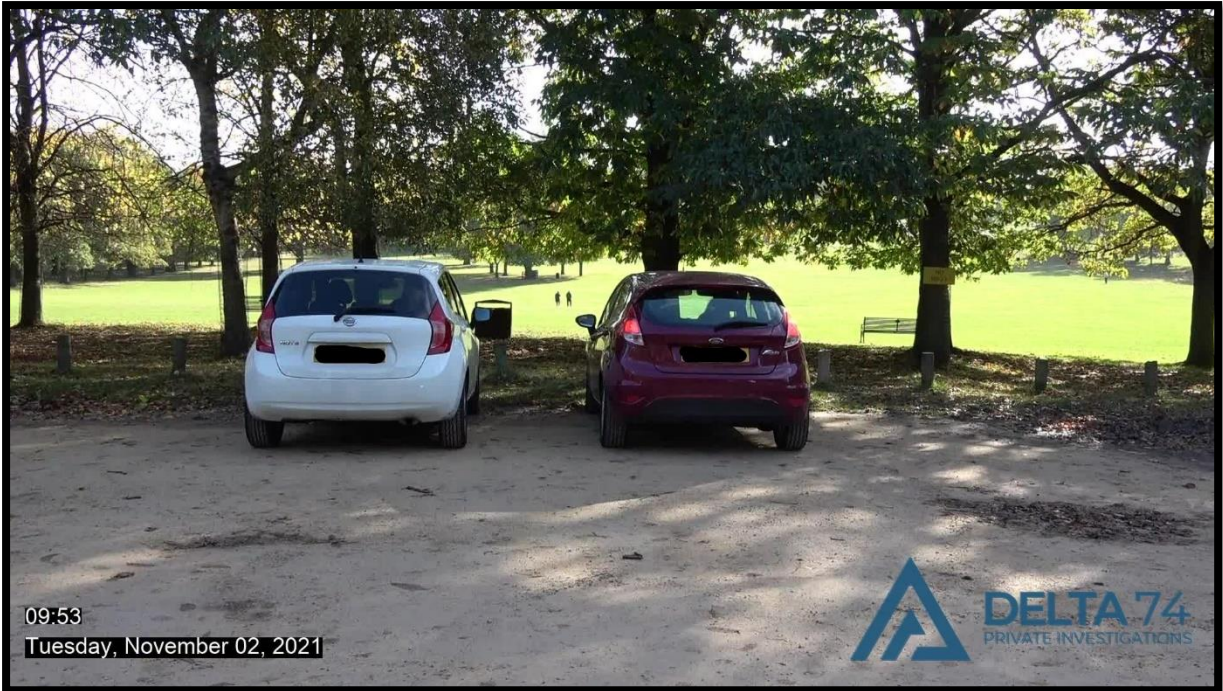
09:42 A mobile follow ensued. Charlotte followed James' lead.



09:50 Charlotte turned in for Wollaton Park. James at this point in the surveillance had already arrived at Wollaton Park.



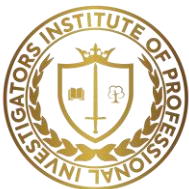

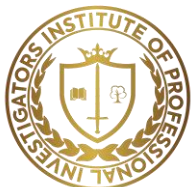

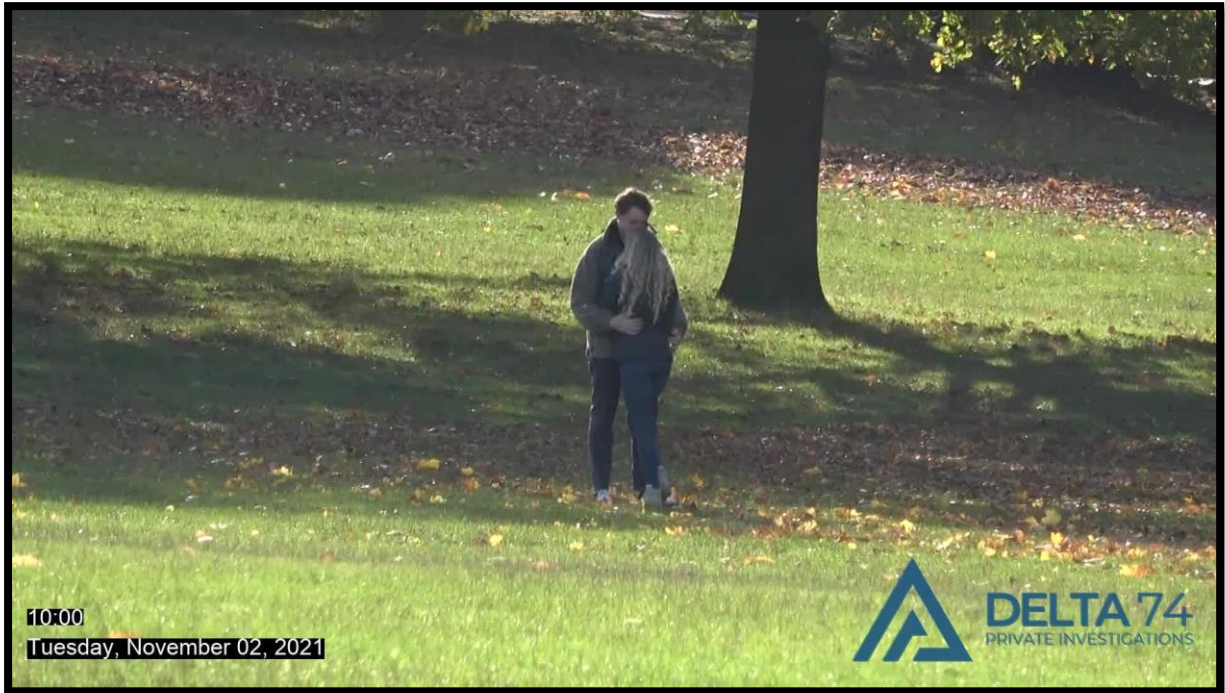

The pair walked through the park and embraced each other. The relationship being monitored was not believed to be in its early stages and both subjects were comfortable with each other.

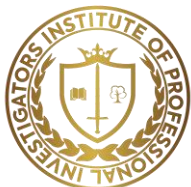

Once back at their vehicles the subjects shared a kiss before departing in their respective vehicles.



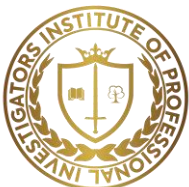
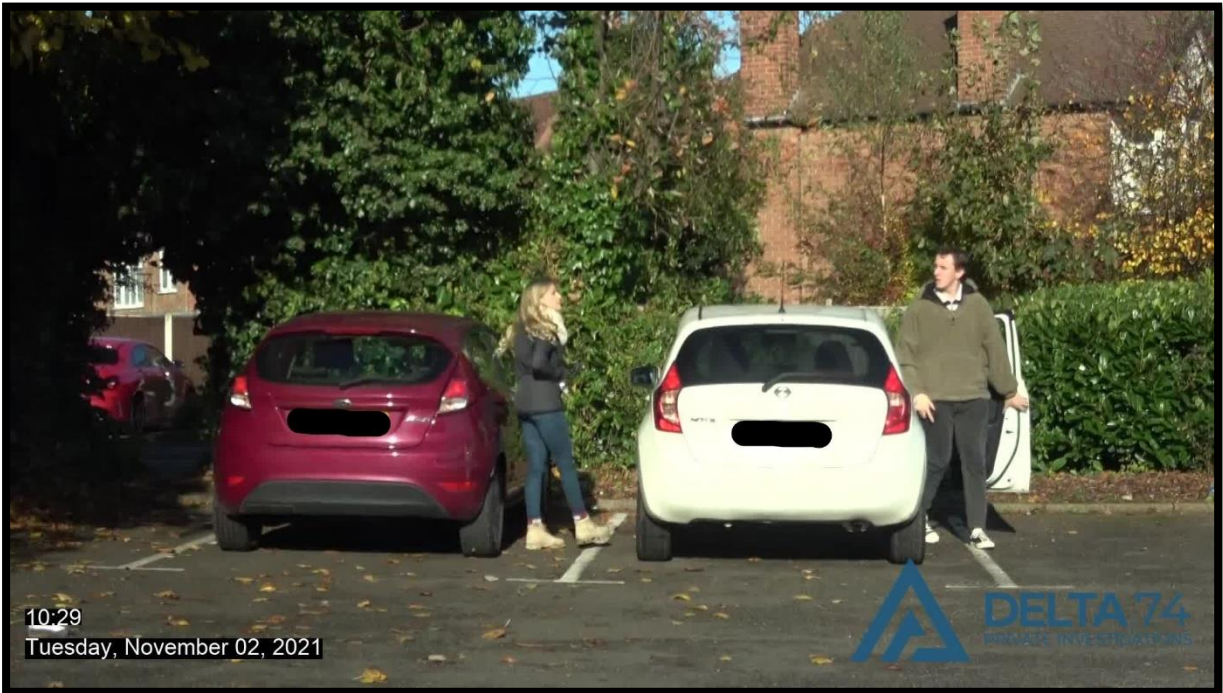

10:36 The pair were seated in the dining area of the pub without drinks at that stage.



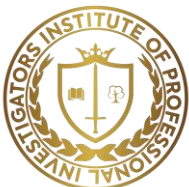
10:52 James ordered food and drinks for both subjects using a bank card. It is not confirmed which card or type.

The pair departed and went in separate directions at this point. Here James became the main focus for the surveillance period.

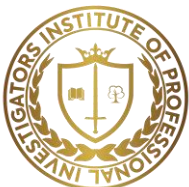

Under instructions a closing shot was taken onto James' home address where observations were ceased with no further sightings of Charlotte or James.



Conclusion/Remarks

During observations it was recorded and evidenced that our subject of investigation Charlotte Smith was having an extra marital affair with her work colleague James Bloggs.

From body language and their interactions this relationship was not brand new and both subjects were comfortable with each other.

Following on from this surveillance period no further observations are recommended from our findings.
